- 2. At the time of issuance of Bidding Documents, original documents as required & submission of applications alongwith copy of CNIC/NTN of the bidder, up-to-date Registration with PEC, KPRA, FBR, Partnership Deed incase of AOP, SECP Incase of Company & an affidavit duly attested by an Oath Commissioner to the effect that the firm/contractor is neither blacklisted nor involved in disputes / litigations on left over works with the University of Peshawar or any other departments, is a must.
- 3. Tenders alongwith E/Money as above in the shape of C/Deposit in f/o the Director of Works, University of Peshawar sealed in an envelope having name of the work, addressed to the undersigned should reach this office on above schedule, which will be opened by the Committee in the presence of the concerned bidders.
- 4. The successful bidder at his own cost and efforts will procure/arrange all sorts of material/equipment.
- 5. In light of the KPPRA Notification No.KPPRA/M&E/Estt:/1-17/2019-20 Dt.12<sup>th</sup> June, 2020, incase the quoted rate/bid is more than 10% below the engineer estimate, the additional bid security shall be sought from the successful bidder **only** to the extent of bid more than 10% below the engineer estimate in the form of %age. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below the engineer estimate. Such security shall be deposited within 3-days from the issuance of Letter of Acceptance. Otherwise, the bid security shall be forfeited & legal proceedings against the bidder who repudiated the contract under KPPRA Rules shall also be initiated & the contact shall be offered to the next lowest bidder as per prescribed procedure.
- 6. Conditional / incomplete tenders, or having any disfiguring, overwriting & manipulation will be straight away rejected.
- 7. All Govt Taxes shall be accordingly deducted as per prescribed rules in vogue.
- 8. In case bids become tie, the lowest bid will be decided through a free toss, which shall be final.
- 9. The competent authority reserves the right to reject a bid with solid justification in light of the rules.
