- 7. The bid shall invariably be accompanied with separate CDRs of prescribed Tender Fee (No-Refundable) and earnest Money @ 2% of bid cost (Refundable), both drawn in the name of The Treasurer, University of Peshawar.
- 8. Bids submitted without prescribed Tender fee or Earnest Money shall be liable for rejection at the time of Tender opening. Tender fee and Earnest money shall be submitted separately along with each Tender.
- 9. The bidders for Tender No.2 shall present sample unit/piece at the time of bid opening.
- 10. Tenders will be opened in the Committee Room No.3, Main Administration Block, University of Peshawar in the presence of the bidders.
