CONDITIONS:

1. Bidding Documents will be issued to the eligible contractors/firms/companies (**owners only**) on production of original documents as required & upon submission of applications alongwith copy of CNIC/NTN of the applicants, up-to-date Registration with PEC, KPRA KNTN, partnership deed/registration with SECP if required & an affidavit duly attested by an Oath Commissioner to the effect that the applicant is neither blacklisted nor involved in any dispute / litigations on left over works with the University of Peshawar or any other departments.
2. Tenders alongwith Earnest Money as above in the shape of Call Deposit in f/o the Project Director, IPCS, University of Peshawar sealed in an envelope having name of the work, addressed to the undersigned should reach this office on above schedule, which will be opened by the Steering Committee in the presence of the concerned bidders.
3. The successful bidder at his own cost and efforts will procure all sorts of material/equipment.
4. In light of the KPPRA Notification No.KPPRA/M&E/Estt:/1-5/2016 Dt.24th May, 2016 & No.KPPRA/M&E/Estt:/1-5/2016 Dt.6th June, 2017, the bidders who quote their bids more than 10% below the engineer's estimate shall submit an Additional Security in the form of call deposit equal to 8% of the estimated cost, otherwise such bid will be considered as non-responsive & the 2nd lowest bidder and so on will be considered accordingly.
5. Conditional / incomplete tenders, or having any disfiguring, overwriting & manipulation will be straight away rejected.
6. NOC/Clearance from PESCO shall be responsibility of the selected bidder.
7. All Govt taxes will be deducted as per prescribed rules in vogue.
8. In case bids become tie, the lowest bid will be decided through a free toss, which shall be final.
9. The competent authority reserves the right to reject a bid with solid justification in light of the procurement rules.
