CONDITIONS:

- Only the Contractor personally, Owner of the Firm/Company or Partner having authorization in the documents of the Company/Firm's will be issued the Tender Documents by this office on non-refundable fee of Rs.3000/- in the shape of Deposit at Call, Demand Draft or Pay Order in f/o the Treasurer, University of Peshawar.
- At the time of issuance of the Tender Documents, original documents must be produced.
- Written application alongwith the following shall be submitted for issuance of Tender Documents:
 - Copy of CNIC/NTN of the prospective bidder.
 - Up-to-date Registration with PEC, FBR & KPRA.
 - Up-to-date Enlistment with Public Health Engineering Dept Khyber Pakhtunkhwa.
 - Partnership Deed incase of AOP / SECP incase of Company.
 - An affidavit duly attested by an Oath Commissioner to the effect that the applicant has never been blacklisted nor involved in disputes/litigations any where and that the documents attached with the application are correct & nothing has been concealed. Full name of the Oath Commissioner with his contact number & information must be mentioned.
- Before issuance of Tender Documents all essential requirements/documents as per S.No.1, 2 & 3 above will be accordingly checked with the check list.
- Tenders alongwith Earnest Money as above in the shape of Deposit at Call from bidder's account only in f/o the Treasurer, University of Peshawar sealed in an envelope having name of the work and bidder, addressed to the undersigned should reach by post/courier service this office on above schedule.
- Bids will be opened by the Committee in the presence of the concerned bidders.
- The successful bidder at his own cost & efforts shall procure/arrange all sorts of material/equipment.
- As prescribed vide **S.R.O.(13)/Vol: 1-21/2021-22 Peshawar, the September 15, 2021**, the contractors quoting their bids more than 15% below on Engineers' Estimate shall submit alongwith their bids an **Additional Security** to the extent of their bid/rates more than 15% below on engineer's estimate in the form of percentage in the shape of Deposit at Call from bidder's account in f/o the Treasurer, University of Peshawar. Incase of bid more than 30%below, detailed rate analysis may also be submitted in the manner as prescribed in the above SRO.
- Conditional / incomplete tenders, or those having any disfiguring, overwriting & manipulation will be straight away rejected.
- Bids quoted must be inclusive of all govt taxes/duties & all Govt Taxes will be accordingly deducted as per prescribed rules in vogue.
- In case tenders become tie, the lowest bid will be decided through a free toss, which shall be final.
- The competent authority reserves the right to reject/accept any or all the bids with solid justification in light of the rules.
