Conditions:

- Only the Contractors personally, Owner of the Firm/Company or Partner having authorization in the documents of the Company/Firm's will be issued the Bid Documents on non-refundable fee of Rs.1000/- in the shape of Deposit at Call, Demand Draft or Pay Order in f/o A/c Treasurer, University of Peshawar.
- 2. At the time of issuance of the Bid Documents, original documents must be produced.
- 3. Written application along with the following shall be submitted for issuance of Bid Documents:
 - a) Copy of CNIC/NTN of the prospective bidder.
 - b) Up-to-date Registration with PEC, FBR & KPRA.
 - c) Partnership Deed in case of AOP / SECP in case of Company.
 - d) An affidavit duly attested by an Oath Commissioner to the effect that the applicant has never been blacklisted nor involved in disputes/litigations anywhere and that the documents attached with the application are correct & nothing has been concealed. Full name of the Oath Commissioner with his contact number & information be mentioned.
- 4. Bids alongwith Bid Security as above in the shape of Deposit at Call from bidder's account only in f/o the Treasurer, University of Peshawar sealed in an envelope having name of the work & bidder, addressed to the Project Accounts Officer should reach through courier service/by-post/by-hand as per detail given above.
- 5. Bids will be opened by the concerned Committee in the presence of the concerned bidders.
- 6. The successful bidder at his own cost & efforts shall procure/arrange all sorts of material/equipment.
- 7. As prescribed vide <u>S.R.O.(14)/Vol: 1-24/2021-22 Peshawar, the May 10, 2022</u>, the contractors quoting their bids more than 10% below upto 20% below on Engrs' Estimate shall submit along with their bids an Additional Security @8% of the Engineer's Estimate in addition to 2% Bid Security. Otherwise, the bid will be considered as 'non-responsive' with forfeiture of 2% Bid Security & the 2nd lowest bidder & so on will be considered. In case of rate more than 20% below, an additional security equal to the differential amount of submitted bid &

engr's estimate along with detailed rate analysis shall be submitted in addition to 2% Bid Security, otherwise the bid will be considered as 'non-responsive' with forfeiture of all the securities submitted with such bid and the 2nd lowest bidder and so on will be considered. Additional securities shall be submitted in f/o Treasurer, University of Peshawar & the above referred SRO will be followed in letter and spirit.

- 8. Conditional, incomplete bids or those having disfiguring, overwriting & manipulation will be straight away rejected.
- 9. Bids quoted must be inclusive of all govt taxes/duties & the same will be accordingly deducted as per prescribed rules.
- 10. In case Bids become tie, the lowest bid will be decided through a free toss, which shall be final.
- 11. The competent authority reserves the right to reject/accept any or all the bids with solid justification as per rules.
