- 2. At the time of issuance of the Tender Documents, original documents must be produced.
- 3. Written application alongwith the following shall be submitted for issuance of Tender Documents:
  - a) Copy of CNIC/NTN of the prospective bidder.
  - b) Up-to-date Registration with PEC, FBR & KPRA.

- 6. In the first phase only the technical bids will be opened, whereas, in the second phase financial bids of the technically qualified bidders will be opened for which schedule will be shared with bidders later on.

As prescribed vide SRO.(14)/Vol: 1-24/2021-22/6058-71 Peshawar, the May 10, 2022, the bidders quoting their bids more than 10% below upto 20% below on Engrs' Estimate shall submit alongwith their bids an Additional Security @8% of the Engineer's Estimate in addition to 2% Bid Security.
