Renewal of PUTF Membership

As per approved constitution of PUTF, 1994 all permanent teaching staff members are eligible for membership. Initially the membership fee was one day salary per year. Since the beginning, membership fee was not deposited on regular base. The committee of administration revised this procedure in its meeting on 4.6.2018 and subsequent approval of committee constituted on 19.8.2018 vide notification No. 1221/Estt and 2nd meeting of committee of administration dated 9.10.2018,has granted approval for renewal of membership and establishment of Teachers' Welfare Fund (TWF). New approved membership fee is Rs. 250/- per month. Fifty percent of the collected membership fee will go to Teachers' welfare fund (TWF) and will be used to help the needy members. The fund will be utilized for the benefit of all faculty members. The following incentives will be offered to all teaching staff.

1.1 Incentives to PUTF Members

The Peshawar University Teachers' Foundation (PUTF), after renewal of membership and creation of Teachers' Welfare Fund (TWF) will offer two types of financial support i.e. Non-Refundable Financial Support and Refundable Financial Support to its members. The program is based on the calculations as per **Annexure-A**.

- 1.1.1 Nonrefundable financial support will be provided to the members of PUTF on the occasion of death of a member and major illness (**See Annexure-B**). This program will be launched when 500 membershipsis achieved.
 - a. PUTF will offer Nonrefundable Financial Support (NRS) to three members every year as per Annexure A.
 - b. Financial support in case of death and major illnesses will be extended to all members irrespective of the membership duration.
 - c. Major illnesses include surgery related to heart, brain and kidney. For other major illness, the case will be forwarded to Committee of Administration.
 - d. In case of major illness, if PUTF receives more than three applications, the matter will be decided by the Committee of Administration.
- 1.1.2 Refundable loans (soft loan) will also be provided to the members for self-marriage and children's marriage, House Repair, Emergency, Outdoor Medical Treatment and

Research Advance etc. (**See Annexure-C**). In order to consider and coordinate requests for financial assistance to deserving applicants.

- a. PUTF will offer soft loan to 3-5 members as per Annexure A.
- b. For soft loan employee must be member for at least two years.
- c. Such loan will be returned in 24 equal installments. The deduction will be made at source. On retirement, the installment will be deducted from the pension of an employee.
- d. Each year, members will be informed through notification. Teachers'/Employees' interested in soft loan will submit application within specified period of time.
- e. If PUTF receives more than 3 applications, the matter will be decided through lucky draw.
- f. Successful loan applicants will be required to provide indemnity bond on stamp paper of Rs. 100 to guarantee the refund of loan.
- 1.1.3 Transport facility with 50% discount from the market rate: As per old practice, this facility will be available to PUTF members only.
 - a. The service will be based on "First come first serve" basis.
 - b. Each member will be required to pay the charges as soon as possible but not later than a month. In case of delay, the charges will be deducted from their salary at source.

1.2 Membership Rules

- 1. Each and every employee of the University of Peshawar is member of PUTF.
- 2. To keep the membership active, membership fee will be deducted from the salary of each faculty member at source at the rate as defined by Committee of Administration of PUTF.
- 3. Each member has the right to de-activate his/her membership any time without a claim for refund of his membership fees. For this he/she will inform the PUTF office in writing (see Annexure-D). If a member wants to re-activate his/her membership, he/she will be required to deposit membership fee for the entire de-activation period.
- 4. The Board of Director has the right to suspend and /or cancel the membership (subject to the approval of Committee of Administration) on the following grounds. The monthly fee will be deducted for the suspension period. To avoid this deduction, the member will inform PUTF office in writing.

- a. Fail to pay the monthly fee for more than three months.
- b. Failing to abide by the Rules and Regulations as set forth herein and asmodified from time to time.
- c. Damage resources of PUTF and fail to correct/compensate the same within specified period of time.
- d. In case of suspension or cancelation of membership, no refunds of membership fees or other payment will be permissible.
- e. Abusive treatment PUTF personnel or employees.

Financial Support

Total employees = 650

Membership expected = 500

Monthly fee = 250

Monthly income = 500 *250 = 125000

Income per year = 125000 * 12 = 1500000/-

Money allocated for financial support @ 50% of the total income =750000/-

Money for nonrefundable financial support = 107142 * 3 = 321428/-

Money for refundable financial support = 107142 * 4 = 428568/-

Note: The committee of administration shall have the right to increase membership fee and number of financial support in both categories.
