MINUTES OF THE MEETING OF THE ACADEMIC COUNCIL HELD ON SEPTEMBER 09, 2014

Meeting of the Academic Council was held on 09.09.2014 at 10:00 A.M. in the Conference Hall of Sir Sahibzada Abdul Qayyum Khan Museum of Archaeology and Ethnology. The meeting was presided over by the Vice-Chancellor. List of participants is attached as per **Annexure-A**.

The meeting started with recitation from the Holy Quran by Prof. Dr. Miraj-ul-Islam Zia, Chairman, Department of Islamiyat. After welcoming remarks of the Vice-Chancellor, regular agenda was taken up for discussion in the following order:

Item No.1 Nominee of the Academic Council on the Discipline Committee

As required under Section-11(1)(ii) of the First Statutes of the University of Peshawar Act-2011, the Academic Council nominated Prof. Dr. Miraj-ul-Islam Zia, Department of Islamiyat and Prof. Dr. Muhammad Ismail, Department of Pharmacy, as members of the Discipline Committee, for a period of two years.

Item No.2 Addition of New Courses in M.Phil/Ph.D Programme Offered by the National Centre of Excellence in Physical Chemistry

As required under Section-25(2)(g) of the University of Peshawar Act-2011, the Academic Council recommended addition of New Courses in M.Phil/Ph.D. Programme offered by the National Centre of Excellence in Physical Chemistry with the instructions to codify the courses in accordance with Notification No. 37/A-II/Academic, dated 28.03.2011.

Item No.4 Report of the Committee Constituted by the Academic Council in its Meeting held on 12.02.2014

The Academic Council appreciated the efforts of the Dean, Faculty of Islamic and Oriental Studies and members of the Committee for updating and bringing the courses of BA (Hons) of Sheikh Zayed Islamic Centre at par with the courses of MA Islamiyat and MA Arabic (Previous year) and recommended admissions of the students of BA (Hons) of the Centre [Islamic Studies and Arabic Group in MA Islamiyat (Final year). The Council allocated 03 seats in the morning class which shall be selected on entry-test basis conducted by the Department. Rest of the students shall be admitted in the evening/self-support class on prescribed evening fee.

The Academic Council further recommended admission of the students of BA (Hons) of the Centre in MA Arabic (Final) with morning fee and in MA Qur'anic Studies (Final) run by the Centre.
