TERMS & CONDITIONS

1. The sealed tenders, complete in all respects, must reach the undersigned at the time and date notified in the advertisement. Late receipts shall not be entertained, whatsoever the reason may be. The bid rates must be valid for 90 days.
2. The bidders must submit with their bids detailed specification and official catalogues if any of the manufacturer/ country of the origin, etc.
3. Tender must be type written/ in printed form. Rates should be quoted both in figures and words. By Hand submission, Incomplete and conditional bids will not be accepted. There should be no crossing, cutting or overwriting etc. All the pages of the tender and as well as the accompanied documents are essential to be properly signed by the bidder.
4. Each bid must accompany earnest money @ 2% as CDR / bank draft / pay order in favor of the Treasurer, the University of Peshawar Khyber Pakhtunkhwa.
5. The rates should be quoted on FOR basis. Rates should be inclusive of all applicable taxes. The bidder must submit a valid sale tax, income tax, trade & professional tax certificates with the bid.
6. As per KPPRA rules quantity of each item may be increased or decreased.
7. The successful bidder / supplier shall execute a contract agreement on Rs. 100/- stamp paper (as per attached specimen) for the supply of goods in accordance with the approved tender specifications and abiding all terms and conditions and will provide 10% security bond of the total offers as bid security in the shape of bank/insurance warranty within 15 days after issuance of supply order. The bid security will be returned to bidder after the successful completion period of the contract.
8. The delivery must be completed within 60 days for imported items and 30 days for the ex-stock.
9. The items must be brand new of standard quality and complete in all respect with original packing of manufacturer and strictly confirming to the given specifications. The items if found substandard, will not be accepted and returned to the supplier on his own cost.
10. Certificate must be attached showing that the firm has not be blacklisted or debarred by any Government Department.
11. In case, the successful bidder fails to execute the contract strictly in accordance with the terms and conditions laid down in the contract, the security deposited by the bidder shall be forfeited in favor of university and the firm may be blacklisted if deem necessary.
12. Payment shall be made after the successful supply and issuance of satisfactory performance / quality certificate by the concerned principal investigator and countersigned by Chairman, Department of Computer Science, University of Peshawar.
13. The procuring committee has the right to reject any or all bid under rule 47 of Khyber-Pakhtunkhwa public procurement of goods, rule, 2014.
14. The bidders may apply for the single item or for all items.
15. Any dispute whatsoever including the interpretation of this or any other relevant documents, arising in respect of this contract shall be referred to the sole arbitration Vice Chancellor of the University of Peshawar, whose decision shall be final and binding on the parties.
16. A penalty of 0.25% of the total cost of order can be imposed per day upto 10 days for delay on the part of the bidder. A penalty of 0.5% of the total cost of order will be imposed for delay beyond 10 days.

17. The successful bidder / contractor will deposit Performance Security amounting to 10% of the Contract Value in the form of Bank Guarantee from a scheduled bank for the warranty period of the said component.
18. The bidder shall enclose a certificate with their bid as under. The bidder must submit indemnity bond regarding the supplied items. Bid received after the closing date / time will not be entertained.
