Eligibility & How to Apply

1. Be enrolled at one of the four consortium universities - University of Peshawar, Habib University, University of Balochistan and Lahore University of Management Sciences.
2. Demonstrate genuine interest in human rights with a record of practical experience work
3. Submit:
 - The application form + your short CV (max 2 pages) to the focal point person at your university. Merge the documents into a single PDF file, naming the file as "Surname_Name"

Note: This call for applications is issued under the Huqooq-e-Pakistan II programme (2024–2028) supported by the European Union and the Government of Pakistan, and will allow for a special quota of Pakistani applicants. Interested students are asked to disregard any other web application regarding the activity and apply exclusively through this Call for Applications.
